The plasma cannon charges up over time, storing plasma from the reactor in a plasma well. It charges at the following rates:-

Stopped: 6D/turn  
1 Move: 5D/turn  
2 Moves: 4D/turn  
3 Moves: 3D/turn  
4 Moves: 2D/turn

The plasma well can hold up to 30D of plasma. Up to 10D may be used per shot. When the vehicle is destroyed, roll one dice. On a 4+ the plasma reactor melts down, doing the following Capital Scale Damage: 6D/5D/4D/3D/2D/1D, blast radius: 10/20/30/40/50/60m

Yet another design used by the HPL on Fanjin, this incorporates an experimental Loblic Arms plasma cannon. Only 4 of these prototypes exist, but they have proved effective, if massively expensive, vehicles.
